

SIGNATURE VERIFICATION STATEMENT & INSTRUCTIONS

**READ THESE INSTRUCTIONS CAREFULLY.
FAILURE TO FOLLOW THESE INSTRUCTIONS MAY CAUSE YOUR BALLOT NOT TO COUNT.**

1. We have determined that the signature you provided on your vote-by-mail or provisional ballot identification envelope does not match the signature(s) on file in your voter record. In order to ensure that your vote-by-mail or provisional ballot will be counted, a **Signature Verification Statement** must be completed and returned as soon as possible.
2. Your completed **Signature Verification Statement** must be received by the elections official of the county where you are registered to vote no later than 5 p.m. two days prior to certification of the election.
3. You must sign your name below where specified on the **Signature Verification Statement** (Voter's Signature) and include your address.
4. Place your completed **Signature Verification Statement** into a mailing envelope addressed to the Lake County Registrar of Voters office. Mail, deliver, or have your completed **Signature Verification Statement** delivered to the Lake County Registrar of Voters office. Be sure there is sufficient postage if mailed and that the address of the Registrar of Voters office is correct.
5. If you do not wish to send your completed **Signature Verification Statement** by mail or have it delivered, you may submit your completed **Signature Verification Statement** by email or facsimile transmission to your County elections official, or submit your completed **Signature Verification Statement** to a polling place or ballot drop box within Lake County before the close of the polls on Election Day.
6. Please note that the signature provided on the completed **Signature Verification Statement** may be added to your registration record to be used for signature comparison purposes in future elections.

I understand that if I commit or attempt any fraud in connection with voting, or if I aid or abet fraud or attempt to aid or abet fraud in connection with voting, I may be convicted of a felony punishable by imprisonment for 16 months or two or three years.

I understand that my failure to sign this statement means that my vote-by-mail or provisional ballot will be invalidated.
