

## **UNSIGNED BALLOT ENVELOPE STATEMENT & INSTRUCTIONS**

**READ THESE INSTRUCTIONS CAREFULLY BEFORE COMPLETING THE STATEMENT.  
FAILURE TO FOLLOW THESE INSTRUCTIONS MAY CAUSE YOUR BALLOT NOT TO COUNT.**

1. You did not sign your vote-by-mail or provisional ballot identification envelope. In order to ensure that your vote-by-mail or provisional ballot will be counted, your **Unsigned Ballot Envelope Statement** must be completed and returned to the Lake County Registrar of Voters office as soon as possible, but no later than 5:00 p.m. two (2) days prior to certification of the election.
2. You must sign your name below where specified on the **Unsigned Ballot Envelope Statement** (Voter's Signature) and include your address.
3. Place your completed **Unsigned Ballot Envelope Statement** into a mailing envelope addressed to the Lake County Registrar of Voters office. Mail, deliver, or have your completed **Unsigned Ballot Envelope Statement** delivered to the Lake County Registrar of Voters office. Be sure there is sufficient postage if mailed and that the address is correct.
4. If you do not wish to send your completed **Unsigned Ballot Envelope Statement** by mail or have it delivered, you may submit your completed **Unsigned Ballot Envelope Statement** by email or facsimile transmission to your county elections official, or submit your completed Statement to a polling place or ballot drop box within Lake County before the close of the polls on Election Day.

I understand that if I commit or attempt any fraud in connection with voting, or if I aid or abet fraud or attempt to aid or abet fraud in connection with voting, I may be convicted of a felony punishable by imprisonment for 16 months or two or three years.

I understand that my failure to sign this statement means that my vote-by-mail or provisional ballot will be invalidated.
