  - ▶ **MAIL the Statement AND completed Voter Registration form** to the Lake County Registrar of Voters, 255 N Forbes Street, Lakeport CA 95453 so that it will reach this office no later than 12:00 pm on December 1, 2020.
  - ▶ **DELIVER the Statement AND completed Voter Registration form** to the Registrar of Voters office at the Lake County Courthouse, 255 N Forbes Street-Room 209, Lakeport CA no later than 12:00 pm on December 1, 2020.
